

We, ASSIGNORS, warrant that we have full right to convey the interest assigned, and that we have not executed, and will not execute, any agreement in conflict with this agreement; and we hereby further warrant that we will communicate to the ASSIGNEE, its successors, legal representatives, and assigns, any facts known to me respecting the Inventions, and testify in any legal proceeding, sign all lawful papers, execute all divisions, continuing, and reissue applications, make all rightful oaths, and generally do everything possible to aid the Assignee, its successors, legal representatives, and assigns, to obtain and enforce proper patent protection for the Inventions in all countries.

We, ASSIGNORS, authorize and request the Commissioner for Patents of the United States, and any official of any country or countries foreign to the United States, whose duty it is to issue patents or other evidence or forms of intellectual property protection on applications for such protection, to issue the same to the ASSIGNEE, its successors, legal representatives, and assigns, in accordance with the terms of this agreement.
