THIS ASSIGNMENT is made on November 2009

BETWEEN

- (1) AIMM Therapeutics BV a body corporate organised and existing under the laws of the Netherlands and having a place of business at Melbergdreef 45, 1105 BA Amsterdam, the Netherlands (the "Assignor"); and
- (2) Medimmune Limited a body corporate organised and existing under the laws of the England and having a place of business at Milstein Building, Granta Park, Cambridge, CB21 6GH (the "Assignee").

BACKGROUND:

- (A) The Assignor is the proprietor and beneficial owner of the Patents.
- (B) Under Clause 2.1.(a) of the License Agreement dated 6th November 2009 (the "License Agreement") the Assignor has agreed to assign the Patents to the Assignee on the terms set out below.

AGREEMENT:

The parties AGREE as follows:

1 Definitions

In this Assignment unless the context otherwise requires:

"Patents" means those patent applications listed in Schedule 1, as well as any patent registrations ensuing there from and any applicable priority rights.

2 Assignment

- 2.1 In part consideration of the sums set out in Section 4.1.1 of the License Agreement, the Assignor hereby assigns and transfers to the Assignee, which transfer and assignment is hereby accepted by the Assignee, free from all encumbrances, charges, liens or similar rights or other third party rights all right, title and interest in the Patents together with all rights of action, remedies, powers and benefits.

relating to any of the Patents including the right to sue for damages for infringement before the date of this Assignment.

3 Further Assurance

3.1 The Assignor undertakes that, at the request of the Assignee, it will do all acts and things (including, without limitation, making declarations and oaths) and execute all documents that may be reasonably necessary under the law of any country for completing and registering the transfer to the Assignee of the full right, title and interest to any of the rights assigned by Clause 2 of this deed.

3.2 At the request of the Assignee, the Assignor shall provide all reasonable assistance to the Assignee which may be necessary in connection with bringing or defending any proceedings relating to any of the rights assigned or transferred by Clause 2 of this deed, and in accordance with Clause 5 of the License Agreement.

4 Applicable Law and Jurisdiction

4.1 This Assignment and any dispute or claim arising out of or in connection with it shall be governed by and construed in accordance with the laws of the Netherlands, unless mandatory foreign law is applicable, and all disputes and claims arising out of or relating to this Assignment shall be subject to the exclusive jurisdiction of the Courts of the Netherlands to which the parties irrevocably submit.




