to said ASSIGNEE its interest as aforesaid in and to said INVENTION or any part thereof, and in and to said several patents or any of them;

AND ASSIGNOR hereby covenants for itself and its respective legal representatives that it has granted no right or license to make, use or sell said INVENTION, to anyone except said ASSIGNEE, that prior to the execution of this deed, ASSIGNOR's right, title and interest in said INVENTION had not been otherwise encumbered, and that ASSIGNOR has not executed and will not execute any instrument in conflict herewith.
