

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under the Patent Security Agreement in the Patent Collateral, (b) release its security interest in the Patent Collateral, and (c) discharge any and all rights, title and interest it has in and the security interest granted to Agent in the Patent Collateral.
