INTELLECTUAL PROPERTY ASSIGNMENT

Secured Party hereby assigns, transfers and conveys unto Assignee, to the full extent of Secured Party's security interest, all of Debtor's right, title and interest in and to the Marks and all variants thereof, both registered and common law, the goodwill of the business symbolized thereby, and the right to sue and to recover damages and profits for past and future infringement thereof.
- 2. Secured Party further assigns, transfers and conveys unto Assignee, to the full extent of Secured Party's security interest, all of Debtor's right, title and interest in and to the Patent Rights and including all rights of priority and the benefit of filing thereof, and any related continuation, divisional, continuation-in-part or foreign counterpart applications and the right to sue and to recover damages and profits for past and future infringement thereof.
- 3. The Debtor joins in this Assignment to assign, transfer and convey unto Assignee all of its right, title and interest in and to the Marks and all variants thereof, both registered and common law, the goodwill of the business symbolized thereby, and the right to sue and to recover damages and profits for past and future infringement thereof.
- 4. The Debtor joins in this Assignment to assign, transfer and convey unto Assignee all of its right, title and interest in and to the Patent Rights and including all rights of priority and the benefit of filing thereof, and any related continuation, divisional, continuation-in-part or



For valuable consideration, the receipt and sufficiency of which are acknowledged, Secured Party hereby fully releases and terminates the Security Agreement filed with the U.S. Patent and Trademark Office and made of record on November 15, 2013 as Trademark Assignment 900272075 recorded at Reel:005155 Frame: 0076 and Patent Assignment 502571212 recorded at Reel: 031645 Frame: 0388.
- 7. The Parties hereto further agree to perform all such acts and execute all such documents requested by Assignee or its successors as are reasonably necessary or desirable to effect, confirm, enable, or evidence the assignment to Assignee. The Parties agree that this Assignment shall be binding upon and inure to the benefits of the parties respective successors, heirs and assigns.
- 8. The persons signing this Assignment on behalf of Secured Party, Debtor and Assignee represent and warrant that they have full power and authority to effect the assignment of rights, title, and interest set forth in this Agreement.
