## ASSIGNMENT

WHEREAS, I, Lawrence Shane INTRAVATOLA (hereinafter "Assignor") have invented: AIR HOSE CANISTER (hereinafter "invention"), described in the U.S. design patent application filed herewith (Attorney Docket No.: 10396-164 (SCHEIN-015)).

WHEREAS, AIR SYSTEMS, INC. d.b.a. The Assignor hereby agrees, for both the Assignor and the Assignor's legal representatives, that the Assignor:

will assist the Assignee in the prosecution of the patent application identified above; in the making and prosecution of any other patent applications in the United States and/or in any countries around the world that the Assignee may elect to make covering the invention, and in vesting in the Assignee like exclusive title in and to all such other patent applications and patents; and in the prosecution of any interference which may arise involving said invention, or any such patent application or patent;

will execute and deliver to the Assignee any and all additional papers which may be requested by the Assignee to carry out the terms of this Assignment;

will supply all information and evidence relating to the making and practice of the invention and/or notify Assignee of the location of same, assist Assignee in gaining custody and control of such information and evidence, and immediately notify Assignee should any of such information and evidence be outside of the custody and control of Assignee and assist Assignee in gaining custody and control thereof, and

provide all reasonable aid and assistance required to enforce and defend any patents issued, subject to reasonable payments from the Assignee for time spent, other than as a witness under oath, if not employed by the Assignee while such aid is given.

The United States Patent and Trademark Office and its officials, and all Patent Offices anywhere in the world, are hereby authorized and requested to issue patents to the Assignee in accordance with the terms of this Assignment.
