
WHEREAS, Assignor delivers this Patent Assignment to Assignee pursuant to Section 4.2(a) of the Asset Purchase Agreement.

FURTHER, Assignor hereby authorizes the Commissioner of Patents and Trademarks in the United States Patent and Trademark Office and the officials of corresponding entities or agencies in any applicable jurisdictions to record and register this Patent Assignment upon request by Assignee. Following the Effective Date, upon Assignee's reasonable request and at Assignee's sole cost and expense, Assignor shall take such actions and provide such assistance to Assignee, including the execution and delivery of any affidavits, declarations, oaths, exhibits, assignments, powers of attorney or other documents, as may be reasonably necessary to effect, evidence or perfect the assignment of such Product Patents to Assignee.

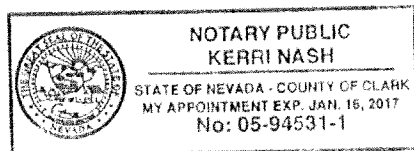
