ViaCyte, Inc., a Delaware corporation (the "Corporation"), a corporation organized and existing under and by virtue of the Delaware General Corporation Law (the "DGCL"), does hereby certify that:

FIRST: The Corporation was organized pursuant to the provisions of the DGC1., on the 17th day of June, 2004.

SECOND: The Corporation owns 100% of the outstanding shares of each class of the capital stock of CyThera, inc., a corporation organized pursuant to the provisions of the DOCL on the 14th day of December, 1999 (the "Subsidiary").
