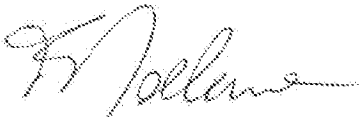

I agree that this general assignment is effective from the 26th day of March 2014.

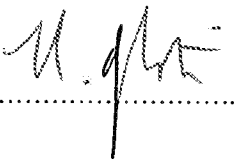
