The ASSIGNORS hereby covenant that each has the right to grant the foregoing assignment.

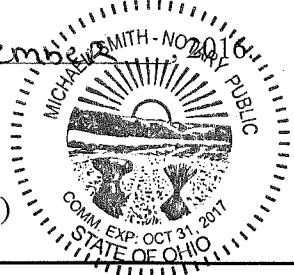
