## ASSIGNMENT

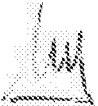
WHEREAS, we, Pedro Jose Santin Navarro and Maria del Mar Rodilla, of C/Ecuador 84, 2A 36204 Vigo, Country of Spain and of C/Marzarico 1, 4 C, 36205 Vigo, Country of Spain, has made new and useful improvements in MOUNTING ENVELOPE; for which application for Letters Patent of the United States has been filed on July 29, 2016 under Serial No. 15/115,289; and

NOW THEREFORE, BE IT KNOWN that for valuable considerations to me paid, the receipt whereof is hereby acknowledged, we, the said Pedro Jose Santin Navarro and Maria del Mar Rodilla, do hereby assign, sell and set over unto the said Dalphi Metal Espana S.A. its successors or assigns, the entire right, title and interest in and to the said improvements and any and all inventions pertaining thereto, said application Serial No. 15/115,289 for the United States patent, all patents granted therefor in the United States of America and elsewhere, and the right to apply for patents therefor in all countries foreign to the United States and to claim for such applications the priority of United States applications, and I hereby request the Commissioner of Patents of the United States, and any official of any country or countries foreign to the United States whose duty it is to issue patents, to issue such patents to the said Dalphi Metal Espana S.A. its successors or assigns; and I further agree to execute such other applications and other instruments and do all other acts as may be deemed necessary by the said Dalphi Metal Espana S.A. its successors or assigns in order to fully secure, protect and preserve its rights to the said improvements and to obtain patents therefor in the United States of America and all countries foreign to the United States, all without further consideration but at the expense of the said Dalphi Metal Espana S.A. its successors or assigns.
