**WHEREAS**, Assignor has invented certain new and useful improvements in USE OF 12-LIPOXYGENASE INHIBITORS FOR INHIBITION OF PLATELET ACTIVATION AND TREATMENT OF THROMBOSIS, set forth in a Provisional application for Letters Patent of the United States, already filed on May 1, 2014 as U.S. Application No. 61/987,129; and has invented certain new and useful improvements in 4-((2-HYDROXY-3-METHOXYBENZYL)AMINO)BENZENESULFONAMIDE DERIVATIVES AS POTENT AND SELECTIVE INHIBITORS OF 12-LIPOXYGENASE, set forth in a Provisional application for Letters Patent of the United States, already filed on October 10, 2013 as U.S. Application No. 61/889,396; and as set forth in an International application of the World Intellectual Property Organization, already filed on October 10, 2014 as Application No. PCT/US14/60174; and
