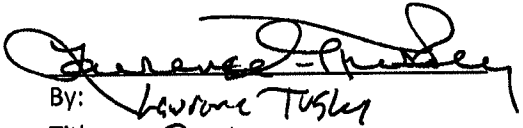
WHEREAS, ASSIGNEE, is desirous of acquiring ASSIGNOR'S right, title and interest in and to the PATENT RIGHTS;
