Assignors further promise and agree to assist the Assignee in any lawful manner in the prosecution of the Patent Application and in any proceeding regarding any patent for the Invention before any tribunal in any jurisdiction whether the same is a court or an agency of the jurisdiction in which the patent for the Invention may be or has been issued, and, in furtherance thereof, agrees to perform all rightful acts, to provide testimony and advice and to execute all papers necessary, expedient and permissible in connection with any such proceeding.
