**Portable Shooting Stabilization Clamp**



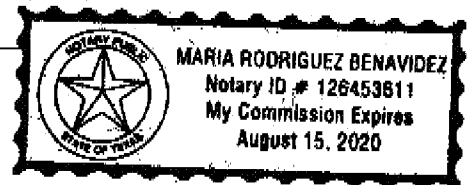
