**SETTLEMENT AND PATENT LICENSING AGREEMENT**

This Settlement and Patent Licensing Agreement (“Agreement”) is entered into by and between **JOSEPH SMITH** (“Licensor”), an individual residing in Texas, and **ORBCOMM INC.** (“ORBCOMM”), a Delaware company (collectively referred to herein as the “Parties” and individually as “Party”).

**BACKGROUND**

**WHEREAS**, Licensor is the sole and exclusive owner of **U.S. PATENT NO. 6,611,686** and all related patent applications, corresponding foreign patents and foreign patent applications, and all continuations, continuations in part, divisions, extensions, renewals, reissues and re-examinations relating to all inventions thereof, which are collectively referred to as “the ‘686 Patent”; and

**WHEREAS**, Licensor is willing to exclusively license the ‘686 Patent to ORBCOMM and ORBCOMM in turn, desires to acquire all substantial rights in and to the ‘686 Patent.

**NOW, THEREFORE**, in consideration of the promises and mutual covenants contained herein and for other good and valuable consideration, Licensor and ORBCOMM agree as follows:

- 3.2. EXCLUSIVE LICENSE. Upon the dismissal or final judgement of Licensor's pending claims against SkyBitz, Inc., Licensor grants to ORBCOMM a worldwide, exclusive right and license under the '686 Patent to make, have made, use, import, offer or sell products or services covered by the '686 Patent, including the exclusive right to grant sublicenses, to sue, litigate and settle cases for damages including for past, present and future damages and to seek and obtain injunctive or any other relief for infringement of the '686 Patent. ORBCOMM's exclusive rights shall include the exclusive right to assert the '686 Patent which shall be exclusive, even as to Licensor, with respect to any and all parties. The exclusive license to ORBCOMM is understood to be subject to the previously granted non-exclusive licenses disclosed pursuant to Section 7.1.3.
