ACKNOWLEDGEMENT AND ASSIGNMENT

The following employees and their employer, Shandong Haichuan Hair Arts Co., LTD., a manufacturing company located in Qingdao, China, and whose address is 8-9 FL, Zhongtianheng Business Building, 66 Nanjing Road, Qingdao, China (collectively designated as the "FACTORY") created some initial, rough, preliminary and conceptual samples for a possible weavable wig product that could be sewn into a user's hair (the "SAMPLES"). The SAMPLES were then shared with Midway International, Inc., a corporation of California whose address is 13131 East 166th Street, Cerritos, CA 90703. Midway and its employees (collectively designated as the "MIDWAY"), have, through substantial time and effort, subsequently materially improved upon and refined the SAMPLES into Midway International, Inc.'s final, marketable WVAWG products (the "MIDWAY'S WVAWG PRODUCTS"). MIDWAY intends to have the MIDWAY'S WVAWG PRODUCTS manufactured by Manufacturer. This Agreement concerns the assignment of rights, if any, in the SAMPLES that were shared with MIDWAY.

MIDWAY had expressed its intention to file one or more U.S. Patent Applications for the MIDWAY'S WVAWG PRODUCTS and requires acknowledgement from FACTORY to MIDWAY that FACTORY has and makes no claim of inventorship or of being an inventor of any part of MIDWAY'S WVAWG PRODUCTS or any inventions included in them. Shandong Haichuan Hair Arts Co., LTD. confirms that the Individuals listed above are all of the employees of Shandong Haichuan Hair Arts Co., LTD. who had any creative or intellectual input into the creation of the initial, rough, preliminary and conceptual samples for the MIDWAY'S WVAWG PRODUCTS, and that FACTORY will benefit from any manufacture of the MIDWAY'S WVAWG PRODUCTS by Shandong Haichuan Hair Arts Co., LTD. at Midway's request.

Accordingly, for good and valuable consideration, receipt and sufficiency of which is hereby acknowledged, FACTORY and the Individuals listed above hereby:

- 1) acknowledge that MIDWAY exclusively owns the entire right, title and interest in the MIDWAY'S WVAWG PRODUCTS and all innovation and inventions included in the MIDWAY'S WVAWG PRODUCTS in the United States and any foreign countries;
- 2) transfer and assign to MIDWAY any right, title and interest in the MIDWAY'S WVAWG PRODUCTS, if any, that FACTORY and/or the Individuals listed above may otherwise have and that MIDWAY may not currently own;
- 3) authorize and request the Commissioner of Patents to issue any and all such Letters Patent granted upon the MIDWAY'S WVAWG PRODUCTS exclusively to MIDWAY, its successors and assigns, including any divisions, continuations, and continuations-in-part of any application filed by MIDWAY on the MIDWAY'S WVAWG PRODUCTS, and in and to any and all reissues, reexaminations, extensions, or counterparts of the above-identified applications, and in and to any and all priority rights, Convention rights, and other benefits accruing or to accrue to us with respect to the filing of applications for patents or securing of patents in the United States and foreign countries


FACTORY and MIDWAY further acknowledge as follows:

- 4) They acknowledge that if FACTORY is not able to fulfill MIDWAY's orders for MIDWAY'S WVAWG PRODUCTS within the discussed lead time, MIDWAY may purchase the shortage quantity of MIDWAY'S WVAWG PRODUCTS from another factory after discussion with FACTORY;
- 5) They acknowledge that if MIDWAY's order quantities are reduced for a given month to below the production capacity discussed between MIDWAY and FACTORY, this will be considered as an authorization by MIDWAY for that particular month for the FACTORY to, after discussion with MIDWAY, use the left over production capacity to sell goods to other markets outside of the US. All of MIDWAY orders will continue to have priority over any other orders FACTORY may receive for MIDWAY'S WVAWG PRODUCTS; and
- 6) They acknowledge that any increase or decrease to the production capacity is to be discussed with MIDWAY first before any adjustments are made.

FACTORY hereby grants to MIDWAY or its designated representative, authority and power to insert on this Acknowledgement and Assignment any further identification that may be necessary or desirable for purposes of recordation of this Acknowledgement and Assignment. Shandong Haichuan Hair Arts Co., LTD. further warrants that the person signing below on behalf of Shandong Haichuan Hair Arts Co., LTD. has authority to do so, and to bind the company.


