## RELEASE OF SECURITY INTERESTS IN PATENTS

B. WHEREAS, Grantee wishes to terminate and release, without representation or warranty, its security interest in and to the Released Collateral as provided in this Release.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Grantee hereby terminates and releases, without representation or warranty, its security interest in and to the Released Collateral and terminates the Patent Security Agreement. Grantee acknowledges that this Release may be filed along with any other necessary documentation with the United States Patent and Trademark Office (the "USPTO") or any other governmental office to evidence the release granted herein at the sole expense of the Grantor. Grantee authorizes the Grantor to record this Release with the USPTO and other applicable registry at the sole expense of the Grantor and agrees to provide the Grantor with any information and additional authorization necessary to effect the release of Grantee's security interest in the Released Collateral.
