**TERMINATION AND RELEASE
OF SECURITY INTEREST IN PATENTS**

THIS RELEASE dated as of October 13, 2016 (this “**Release**”) is made by Advanced Technology Ventures VIII, L.P., Flybridge Capital Partners II, L.P., MedVenture Associates V, L.P., Kevin Barrett, and Michael Murray Trading Partners L.P. 3. acknowledge and agree that the Grantor and its successors and assigns may rely upon this Release.
4. represent and warrant that it has not transferred or assigned all or any part of the Security Interest in the Patents to any third party, and that it has all necessary authority to execute this Release and grant the releases and discharges and all other rights set forth herein.
