heretofore or hereafter filed for said designs in any foreign countries, and all patents (including all  
continuations, divisions, extensions, renewals, substitutes, and reissues thereof) granted for said designs  
in any foreign countries, and ASSIGNOR hereby authorizes and requests the United States  
Commissioner of Patents and Trademarks, and any officials of foreign countries whose duty it is to issue  
patents on applications as aforesaid, to issue all patents for said designs to ASSIGNEE in accordance  
with the terms of this assignment;

AND ASSIGNOR HEREBY covenants that ASSIGNOR has the full right to convey the interest herein  
assigned, and that ASSIGNOR has not executed, and will not execute, any agreement in conflict  
herewith;

AND ASSIGNOR HEREBY further covenants and agrees that ASSIGNOR will communicate to  
ASSIGNEE any facts known to ASSIGNOR respecting said designs and testify in any legal proceeding,  
sign all lawful papers, execute all divisional, continuation, substitute, and reissue applications, make all  
rightful oaths and generally do everything possible to aid ASSIGNEE in obtaining and enforcing patent  
protection for said designs in all countries.

AND ASSIGNOR HEREBY requests that the attorneys and agents of Lewis Roca Rothgerber Christie  
LLP insert the application number and filing date of the aforementioned application when such information  
is allocated by the United States Patent and Trademark Office.
