ASSIGNMENT

WHEREAS, we, Axel Schubert of Munich, Germany, José Javier Romero-Galeano of Markt Schwaben, Germany, and Max Kessler of Munich, Germany hereinafter ("Assignors"), have invented certain new and useful improvements in A CARTRIDGE DEVICE FOR A MEASURING SYSTEM FOR MEASURING VISCOELASTIC CHARACTERISTICS OF A SAMPLE LIQUID, A CORRESPONDING MEASURING SYSTEM, AND A CORRESPONDING METHOD, for which application for a U.S. Patent was made on December 23, 2008 as U.S. Provisional Patent Application Serial No. 61/140,344 and subsequently filed on December 17, 2009 as U.S. Patent Application Serial No. 12/640,376.

Assignors further covenant and agree that, at the time of the execution and delivery of these presents, Assignors possess full title to the invention and application above-mentioned, and that they have the unencumbered right and authority to make this assignment.

Assignors further covenant and agree, and likewise binds their heirs, legal representatives and assigns, to promptly communicate to said Assignee or its representatives any facts known to them relating to said invention, to testify in any interference or legal proceedings involving said invention, to execute any additional papers which may be requested to confirm the right of the Assignee, its representatives, successors and assigns to secure patent or similar protection for the said invention in all countries and to vest in the Assignee complete title to the said invention and Letters Patent, without further compensation, but at the expense of said Assignee, its successors, assigns and other legal representatives.
