General Corporation Law of the State of Delaware

Woodman Labs, Inc., a Delaware corporation ("**Woodman Labs Delaware**"), does hereby certify to the following facts relating to the merger (the "**Merger**") of Woodman Labs, Inc., a California corporation ("**Woodman Labs California**"), with and into Woodman Labs Delaware, with Woodman Labs Delaware remaining as the surviving corporation of the Merger (the "**Surviving Corporation**"):
