PATENT APPLICATION ASSIGNMENT AGREEMENT

THIS AGREEMENT is made this 19th day of October, 2016, by and between Sandeep Pendharkar with address at Oak 101, SJR Park Vista Apartments, Harlur Road, Off Sarjapura Road, Bengaluru – 560102, Karnataka, India, Venugopal Kolathur with address at Out House Cottage No. 1, B C 43, Camp, Belgaum - 590001, Karnataka, India, and Karthick Gururaj with address at 1201, Anriya Grienberg Apartment, Judicial Layout, Bengaluru – 560064, Karnataka, India (hereinafter “ASSIGNORS”) and Vayavya Labs Pvt. NOW THEREFORE, in consideration of the mutual promises, covenants, warranties, and other good and valuable consideration set forth herein, the Parties agree as follows:

2. Assignment. Assignors hereby assign to Assignee, its successors, representatives and assigns, all right, title and interest in the Patent Application and in all divisions, renewals and continuations thereof, and in all letters patent granted thereon, including all reexaminations, extensions and reissues thereof. 4. Assignors Representations and Warranties. Assignors hereby represent and warrant that they have the legal right and authority to execute this Agreement, and to validly assign the entire interest in the Patent Application to Assignee. Assignors further represent and warrant that they have not executed any other agreement that would conflict with the terms of this Agreement, nor shall he execute any such agreement in the future.
5. Further Actions. Assignors hereby agree to execute any further agreements and to take any further actions necessary to aid Assignee in perfecting its interest in the Patent Application, and in any letters patent granted thereon, and in enforcing any and all protections or privileges deriving from the Patent Application or from said letters patent.
6. Governing Law. This Agreement shall be construed in accordance with, and governed in all respects by, the laws of the State of Karnataka, India without regard to conflicts of law principles.
7. Counterparts. This Agreement may be executed in several counterparts, each of which shall constitute an original and all of which, when taken together, shall constitute one agreement.

8. Severability. If any part or parts of this Agreement shall be held unenforceable for any reason, the remainder of this Agreement shall continue in full force and effect. If any provision of this Agreement is deemed invalid or unenforceable by any court of competent jurisdiction, and if limiting such provision would make the provision valid, then such provision shall be deemed to be construed as so limited.


