WHEREAS, 王丹 Dan Wang, AKA Tan Wong (Inventor) invented the following inventions:

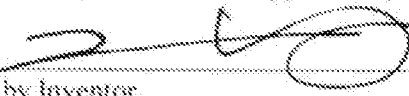
Wang, Dan 14541945 Vapor Generator

The inventor official name in Chinese is 王丹. 王丹 can be Dan Wang or Tan Wong depending on if Mandarin or Cantonese pinyin phonetic transliteration is being used. Dan Wang prefers being called Tan Wong because Dan makes it sound like she has a man's name. Two of the applications on file using one kind of phonetic transliteration, and the other two applications were filed using the other kind of phonetic transliteration. In any case, these names all refer to the same person which is 王丹.
