COVENANT to carry out in good faith the intent and purpose of this assignment, to execute all divisionals, continuations, substitutes, renewals, reissues, reexaminations, and all other patent applications relating to any and all such inventions and improvements; to execute all rightful oaths, declarations, assignments, powers of attorney and other papers; to communicate to EAI all facts and provide to EAI all documents and things known and accessible to the undersigned relating to such inventions and improvements and the history thereof, and testify as to the same in any interference, litigation or other proceeding relating thereto; and generally to do everything possible which EAI shall consider desirable for vesting title to such inventions and improvements in EAI, and to secure, maintain, defend and enforce valid and enforceable patent protection for such inventions and improvements; at the request of EAI and upon prior written arrangement, EAI may reimburse the undersigned for any burdensome expenses in carrying out the above covenants;

AGREE AND ACKNOWLEDGE that the SALE, ASSIGNMENT AND TRANSFER of rights and property set forth herein is and shall be IRREVOCABLE and BINDING upon the heirs, assigns, representatives and successors of each undersigned ASSIGNOR and EXTEND to the successors, assigns and nominees of EAI.

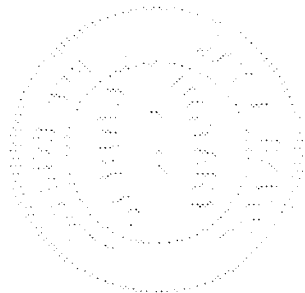


