ASSIGNMENT

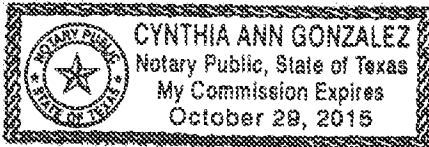

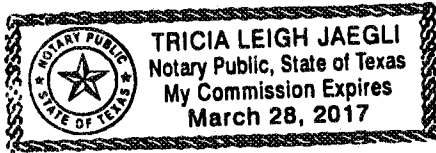



