EXCLUSIVE LICENSE AGREEMENT

Korea Research Institute of Bioscience and Biotechnology, having an address of 125, Gwahak-ro, Yuseong-gu, Daejeon, 34141, Republic of Korea ("KRIBB"), is the owner by assignment of the invention of, and all rights, title, and interest in and to, United States Patent Application 15/120,516 filed August 20, 2016 in the names of Chul Ho KIM, Jeong-Woo SEO, Sun-Yeon HEO, Sung Mok LEE, Jang Min PARK, Baek Rock OH, and You Ree JUNG, for METHOD FOR PRODUCING 1,3-PROPANEDIOL USING MICROORGANISM VARIANT WITH DELETION OF 2,3-BUTANEDIOL SYNTHETIC GENE (such invention and rights, title, and interest hereafter referred to as the "Patent Rights"), by virtue of an assignment to KRIBB by Chul Ho KIM, Jeong-Woo SEO, Sun-Yeon HEO, Sung Mok LEE, Jang Min PARK, Baek Rock OH, and You Ree JUNG, as heretofore recorded in the assignment records of the United States Patent and Trademark Office.
