

1. The name of the corporation is Research In Motion Corporation, a Delaware corporation (the "Corporation").
2. The Certificate of Incorporation of the Corporation was filed by the Department of State of the State of Delaware on April 11, 2000.
3. The Certificate of Incorporation of the Corporation is hereby amended to change the name of the Corporation from Research In Motion Corporation to BlackBerry Corporation.

To effect such amendment:


Paragraph "1." of the Certificate of Incorporation is hereby amended to read in its entirety as follows:

"1. The name of the Corporation is BlackBerry Corporation."

4. The foregoing amendment of the Certificate of Incorporation was authorized by the unanimous written consent of all the directors of the Corporation and approved by the stockholders of all of the issued and outstanding stock of the Corporation entitled to vote thereon.
