ASSIGNMENT

This Assignment of Patent Rights (this "Assignment") is made of the 16 day of March, 2014 (the "Effective Date") by and between

- (1) FOREST LABORATORIES HOLDINGS LIMITED, a company with an address at 18 Parliament Street, Milner House, Hamilton, Bermuda (the "Assignor"); and
- (2) TREVENA, INC., a company with an address at 1018 West 8th Avenue, Suite A, King of Prussia, Pennsylvania 19406 (the "Assignee")

Recitals

- (A) WHEREAS, the Assignor is a registered owner of U.S. Patent Application No. 61/936,914 filed on February 7, 2014 (the "Patent")
- (B) WHEREAS, the Assignor has agreed to assign to Assignee their entire right, title and interest in and to the Patent, and in and to the inventions disclosed in such Patent.

Agreement

NOW, THEREFORE, in consideration of the mutual covenants contained in this Agreement, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties, intending to be legally bound, agree as follows:

1. Assignment

In consideration of the payment by Assignee to Assignor of the sum of one dollar, the receipt of which is hereby acknowledged, Assignor hereby assigns, sells and transfer to Assignee, the following rights (the "Patent Rights"):

All of Assignor's entire right, title and interest in and to the Patent throughout the world, any rights of priority throughout the world with respect to the Patent, including any divisional, continuation and continuation-in-part applications throughout the world claiming, directly or indirectly, the benefit of, or priority to, the Patent, any patents throughout the world that may be granted to or on any of the foregoing applications ("Subsequent Patents"), any reissues, re-examinations or extensions of such Subsequent Patents, to the full end of the term for which the Subsequent Patents have been granted, reissued, re-examined or extended.

2. Further Action

Assignor agrees, at the reasonable request of Assignee and at the cost of Assignee to: (a) to execute and deliver any further documents and to take any further actions reasonably necessary to enable Assignee to become the registered owner of the Patent Rights and to

secure the benefits of the rights hereby assigned; and (b) to aid in securing and maintaining patent protection for the Patent Rights in the United States and Canada, including, without limitation, cooperating in any proceedings involving examinations, re-examinations, reissues, opposition and cancellation proceedings, interferences, infringement proceedings, court actions and the like.

3. Recordation

Assignor hereby authorizes the United States Commissioner of Patents and Trademarks and, as appropriate, the corresponding officials in any other foreign jurisdiction, to record this Assignment.

4. Governing Law and Jurisdiction


