TERMINATION AND RELEASE OF SECURITY INTEREST IN PATENTS

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN PATENTS**, dated as of October 31, 2016 (“Release”), is made by NewStar Financial, Inc., as administrative agent (“Administrative Agent”) for itself, its successors and permitted assigns, and the other Lenders (as defined in the Credit Agreement referred to below) in favor of each of the entities listed on the signature pages hereof (each a “Grantor” and, collectively, the “Grantors”).

WHEREAS, pursuant to the Credit Agreement dated as of May 7, 2015 (as amended by the First Amendment to Credit Agreement dated as of August 3, 2015, and as further amended, amended and restated, supplemented or otherwise modified from time to time, the “Credit Agreement”) iSqFt Sub, Inc. (f/k/a Blueprint Sub Inc.), a Delaware corporation (the “Borrower”), the other Credit Parties party thereto (collectively, with the Borrower, the “Guarantors”), the Lenders party thereto and the Administrative Agent on behalf of the Lenders under the Credit Agreement, and pursuant to the Notice of Grant of Security Interest in Patents dated as of May 7, 2015 (the “Patent Security Agreement”), each Grantor has granted a continuing security interest in and continuing lien upon the patents and patent applications shown on Schedule A (the “Patents”);

WHEREAS, the Patent Security Agreement was recorded at the United States Patent and Trademark Office (“USPTO”) on May 19, 2015 at Reel 035671 Frame 0837; and

WHEREAS, Administrative Agent (acting at the written direction of the Lenders) now desires to terminate and release the entirety of its security interest in the Patents.

NOW THEREFORE, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, Administrative Agent (for itself and as Administrative Agent for the Lenders) and the Grantors (the “parties”) agree as follows:

SECTION 1. Defined Terms. Capitalized terms used herein without definition shall have the meanings ascribed to such terms in the Credit Agreement or Patent Security Agreement.

SECTION 2. Termination and Release. The Administrative Agent (acting at the written direction of the Lenders), for itself and as Administrative Agent for the Lenders, hereby:

(a) terminates, releases, and discharges its continuing security interest in and continuing lien upon the Patents. Any and all right, title, or interest of Administrative Agent in the Patents and all proceeds thereof, including without limitation, the goodwill of the business connected with the use of, and symbolized by, the Patents and any and all causes of action which may exist by reason of infringement of the Patents, shall hereby cease and become void;

(b) authorizes the recordation of this Release with the USPTO;

(c) releases without any recourse to the Administrative Agent (whether as Administrative Agent or in its personal capacity) and without any statement, representation, warranty, promise or undertaking whatsoever by the undersigned (whether as Administrative Agent or in its personal capacity); and

(d) agrees to execute any other documents and take any further action which is reasonably necessary in any state, country, or jurisdiction that the Grantors may reasonably require to effect the intent and purpose of this Release, provided that all such documents shall be prepared by Grantors' counsel and the cost and expense of such documents and actions shall be borne solely by the Grantors.

This release and the rights and obligations of the parties hereunder shall be governed by, and shall be construed and enforced in accordance with, the laws of the State of New York.

IN WITNESS WHEREOF, the Administrative Agent has caused this Termination and Release of Security Interest in Patents to be duly executed as of the date first set forth above.




