Assignment

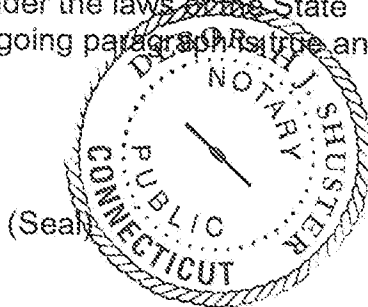
