**RELEASE OF SECURITY INTEREST IN
PATENT COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN PATENT COLLATERAL** (the "Release") is dated as of September 19, 2016 by WILMINGTON TRUST, NATIONAL ASSOCIATION, as Collateral Trustee, successor by merger to WILMINGTON TRUST FSB, (the "Collateral Trustee"), in favor of SAFWAY SERVICES, LLC, a Delaware limited liability company (the "Grantor"). Capitalized terms used but not otherwise defined herein have the meanings given to them in the Pledge and Security Agreement (as defined below).

WITNESSETH

WHEREAS, the Grantor and the Collateral Trustee entered into that certain Pledge and Security Agreement dated as of December 16, 2009 (as amended, restated, amended and restated, modified or supplemented from time to time, the "Pledge and Security Agreement");

WHEREAS, pursuant to the Pledge and Security Agreement, the Grantor executed and delivered to the Collateral Trustee that certain Patent Collateral Assignment and Security Agreement, dated as of February 22, 2013 (the "Patent Security Agreement") and recorded with the United States Patent and Trademark Office ("USPTO") on February 26, 2013 at Reel/Frame No. 29874/686, pursuant to which the Grantor granted to the Collateral Trustee, for the benefit of itself and the other Parity Lien Secured Parties, a continuing security interest in and a general lien upon, and collaterally assigned and transferred to the Collateral Trustee, for the benefit of itself and the other Parity Lien Secured Parties, its Patents (as defined in the Patent Security Agreement) and Collateral (as defined in the Patent Security Agreement);

WHEREAS, the Grantor has requested that the Collateral Trustee release its security interest and general lien in and to the Patents and Collateral in connection with the termination of the Pledge and Security Agreement and the Patent Security Agreement.

NOW, THEREFORE, in consideration of the foregoing, the Collateral Trustee hereby DISCHARGES, TERMINATES and RELEASES, without recourse, representation or warranty, its security interest and general lien in and to the Patents and Collateral, including the patents and patent applications set forth in Schedule I, attached hereto and incorporated herein by reference, and agrees that all the security interest in the Patents and Collateral is hereby discharged, terminated and released. The undersigned hereby transfers and assigns to the Grantor, without recourse, representation or warranty, any and all right, title and interest that the Collateral Trustee may have obtained in, to and under the Patents and Collateral under the Pledge and Security Agreement.
