
The Assignors hereby covenant and agree, for both the Assignors and the Assignor's legal representatives, that the Assignors will assist the Assignee in the


The Commissioner of Patents and Trademarks is hereby authorized and requested to issue patents to the Assignee in accordance with the terms of this Assignment.
