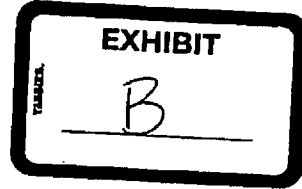

We, the undersigned, being respectively the Senior Vice President-Law and Secretary of American Telephone and Telegraph Company, the surviving corporation certify:

1. The plans of merger have been adopted by the board of directors of the surviving corporation.

2. The name of the surviving corporation is American Telephone and Telegraph Company; its certificate of incorporation was filed in the Office of the Secretary of State of the State of New York on March 3, 1885 and the names of the subsidiary corporations are AT&T Technologies, Inc. (originally known as Interim Holding Corporation) and Bell Telephone Laboratories, Incorporated; their certificates of incorporation were filed in the Office of the Secretary of State of the State of New York on August 19, 1966 and December 27, 1934, respectively.

3. The designation and number of outstanding shares of each class of each subsidiary corporation to be merged, and the number of each such class owned by the surviving corporation is as follows:
