WHEREAS, WaveConnex, Inc., a Delaware corporation, having its principal place of business in Mountain View, California, is desirous of acquiring an interest therein;



Further, we hereby covenant and agree to and with WaveConnex, Inc., and its successors and assigns, at the time of execution and delivery of these presents, that we are the sole and lawful owner of the entire right, title, and interest in and to the invention and the above-identified patent application, and that the same are unencumbered, and that we have good and full right and lawful authority to sell and convey the same in the manner herein set forth.

Further, we agree that we will communicate to WaveConnex, Inc., or its representatives, any facts known to us respecting the invention, and testify in any legal proceedings, sign all lawful papers, execute all subsequent, related provisional, U.S. non-provisional, divisional, continuation, reissue, substitution, and extension applications, execute all necessary assignment papers to cause any and all of said Letters Patent to be issued to WaveConnex, Inc., make all rightful oaths, and generally do everything possible to aid WaveConnex, Inc., and its successors and assigns, to obtain and enforce proper protection for the invention in the United States and in any and all foreign countries.


