Deed of Assignment and Transferral

This deed hereby confirms a previous assignment of intellectual property rights ("INTELLECTUAL PROPERTY ASSIGNMENT"), made on 5 August 2016, but with effect as from 1 August 2016, between **JSR Corporation**, organized under the laws of Japan, having its principal office at 1-9-2 Higashi-Shinbashi, Minato-Ku, Tokyo 105-8640, Japan, and hereinafter referred to as "JSR",

And

DSM IP Assets, B.V., a private company with limited liability, organized under the laws of the Netherlands with its principle place of business at Het Overloon 1, 6411 TE Heerlen, the Netherlands, hereinafter referred to as "DSM IP".

Now, Therefore, the Parties confirm the following in accordance with the INTELLECTUAL PROPERTY ASSIGNMENT:

In exchange for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, JSR, hereby assigns its entire right, title and interest in:


- (A) the patents and patent applications listed in Appendix A (the "Scheduled Patents and Applications");
- (B) any and all patents and patent applications that claim priority to any of the Scheduled Patents and Applications;
- (C) any and all patents and patent applications to which any of the Scheduled Patents and Applications claims priority, whether owned solely or jointly; and
- (D) all renewals, related continuations, continuations-in-part, divisionals, reissues, re-examinations, substitutions, and extensions of any of the patents or patent applications which would qualify herein under subsections (A)-(D); and
- (E) all benefits, privileges, causes of action and remedies relating thereto throughout the world, including, without limitation, all of its rights to: (a) apply for and maintain all registrations, renewals and/or extensions thereof; (b) claim priority under United States law, Japanese law or other international convention; (c) bring actions and recover damages for past, present and future infringement or other violation thereof; and (d) grant licenses or other interests therein.
