ASSIGNMENT AND AGREEMENT

FOR VALUE RECEIVED, We, Timo KRÜGER, a citizen of Germany residing at Kreuzritterstrasse 7, 13465 Berlin, Germany and Dirk MUCHA, a citizen of Germany residing at Kurhausstrasse 36a, 13467 Berlin, Germany hereby sell, assign and transfer to **FIAGON AG MEDICAL TECHNOLOGIES**, an organization duly organized and existing under the laws of Germany and having a principal place of business at Neuendorfstrasse 23b, 16761 Hennigsdorf, Germany, as assignee, and its successors, assigns and legal representatives, the entire right, title and interest for all countries in and to certain inventions relating to improvements in a **NAVIGATION ASSISTANCE SYSTEM FOR MEDICAL INSTRUMENTS**, which is described in PCT International Patent Application No. **PCT/EP2015/058107** filed on **April 14, 2015**, which was transmitted to the United States Patent and Trademark Office by the International Bureau, for which commencement of the national stage in the U.S.A. is sought under an application for Letters Patent of the United States now bearing serial number **15/303,793**, in furtherance of which a Declaration in accordance with 35 U.S.C. 371 is executed by us on even date herewith; and all the rights and privileges under any and all Letters Patent that may be granted therefor.

We request that any and all patents for said inventions in all countries be issued to said assignee, its successors, assigns and legal representatives, or to such nominees as it may designate.

We agree that, when requested, we will, without charge to said assignee but at its expense, sign all papers, take all rightful oaths, and do all acts which may be necessary, desirable or convenient for securing and maintaining patents for said inventions in any and all countries and for vesting title thereto in said assignee, its successors, assigns and legal representatives or nominees.

We authorize and empower the said assignee, its successors, assigns and legal representatives or nominees, to invoke and claim for any application for patent or other form of protection for said inventions filed by it or them, the benefit of the right of priority provided by: (a) the International Convention for the Protection of Industrial Property, as amended, or by any convention which may henceforth be substituted for it; and (b) the Patent Cooperation Treaty, as amended, or by any treaty which may henceforth be substituted for it; and to invoke and claim such right of priority without further written or oral authorization from us.

We hereby consent that a copy of this assignment shall be deemed a full legal and formal equivalent of any assignment, consent to file or like document which may be required in any country for any purpose and more particularly in proof of the right of the said assignee or nominee to claim the aforesaid benefit of the right of priority provided by: (a) the International Convention for the protection of Industrial Property, as amended, or by any convention which may henceforth be substituted for it; and (b) the Patent Cooperation Treaty, as amended, or by any treaty which may henceforth be substituted for it.

We covenant with said assignee, its successors and assigns and legal representatives, that the rights and property herein conveyed are free and clear of any encumbrance, and that we have full right to convey the same as herein expressed.
