AND I HEREBY covenant that I have full right to convey the entire interest herein assigned and that I have not executed and will not execute any agreement in conflict herewith; and agree that I will communicate to ASSIGNEE any and all facts known to me regarding said inventions and improvements and applications whenever requested and will testify in any legal proceeding, sign all lawful papers, execute all divisional, reissue, continuation, or any other applications, and generally do everything possible to aid ASSIGNEE to obtain and enforce proper patent protection for said invention and improvements in all countries.
