Assign, transfer, and convey to the Assignee the entire right, title, and interest in and to said inventions and discoveries and any and all improvements thereon, including said Application for Letters Patent of the United States of America, any and all other applications for Application for Letters Patent on said inventions and discoveries in whatsoever countries, including but not limited to all divisional, continuation, continuation-in-part, foreign filing and PCT applications based in whole or in part upon said inventions and discoveries, or any and all Letters Patent, reissues, reexaminations, and extensions of Letters Patent granted for said inventions and discoveries, and every priority right that is or may be predicted upon or arise from said inventions, said discoveries, and said Letters Patent, as fully and entirely as the same would have been held and enjoyed by Assignors if this Assignment had not been made, together with all claims for damages by reason of past infringement of said Application for Letters Patent, with the right to sue for and collect the same for Assignee's own use, and for the use of Assignee's successors, assigns, or other legal representatives;

2. Authorizes the Assignee to file patent applications in any or all countries on any or all of said inventions and discoveries in the Assignor's name or in the name of the Assignee or otherwise as the Assignee may deem advisable, under any treaties and conventions or otherwise;

3. Authorizes and requests the Commissioner of Patents and Trademarks of the United States of America and the empowered officials of all other governments to issue or transfer said Application for Letters Patent to the Assignee, as assignee of the entire right, title, and interest therein or otherwise as the Assignee may direct;

4. 5.
