NUNC PRO TUNC ASSIGNMENT

WHEREAS, SAMYANG CORPORATION, a corporation duly organized under the laws of the Republic of Korea, with a place of business at 263 Yeonji-Dong, Jongno-Gu, Seoul 110-725 Republic of Korea, (hereinafter "ASSIGNOR") is the owner of U.S. Patent No. 7,537,974, entitled "Photoresist Composition, Method for Forming Film Pattern Using the Same, and Method for Manufacturing Thin Film Transistor Array Panel Using the Same";

The earlier effective date of the present assignment is based on the mutual understanding among ASSIGNOR and ASSIGNEE that the assignment executed on December 13, 2013 and recorded on January 29, 2014 at Reel/Frame 032080/0064 was made in error and the right, title and interest transferred therein should have remained with Samsung Display Co., Ltd.

ASSIGNOR represents that at the time of execution of this Assignment, ASSIGNOR is the owner of all right, title, and interest in and to U.S. Patent No. 7,537,974, and that ASSIGNOR has not assigned, transferred, licensed or encumbered ASSIGNOR'S rights therein, and that ASSIGNOR will not hereafter assign or attempt to assign any rights therein, or take any other action inconsistent with this Assignment.
