## REASSIGNMENT AND RELEASE OF SECURITY INTEREST

This Reassignment and Release of Security Interest is executed as of November 15, 2016, by WESTERN ALLIANCE BANK, an Arizona corporation, successor in interest to Bridge Bank, National Association ("Assignor") for the benefit of VAPOTHERM, INC., a Delaware corporation ("Assignee"), having its principal business address located at 22 Industrial Drive, Exeter, New Hampshire 03833.

### RECITALS

A. WHEREAS, Assignee assigned certain interests in the intellectual property described on Exhibit A (the "IP") to the Assignor pursuant to that certain Amended and Restated Intellectual Property Security Agreement (the "Intellectual Property Security Agreement") dated as of March 20, 2013 and recorded with the U.S. Patent and Trademark Office on April 12, 2013 at reel/frame no. 030208/0453.

B. WHEREAS, Assignor wishes to release and reassign all interest that Assignor may have in the IP listed on Exhibit A.

C. NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which the parties acknowledge, the Assignor hereby releases, terminates and discharges the Security Interest granted under the Intellectual Property Security Agreement solely with respect to the Patent listed on Exhibit A hereto, and any right, title or interest of the Assignor in such Security Interest shall hereby terminate, cease and become void. This Release does not release, relinquish, discharge or terminate the Assignor's security interest in any Intellectual Property or any other asset of the Assignee other than the Patent set forth in Exhibit A hereto. The Assignor hereby consents to the recording of this Release with the USPTO and agrees to duly execute and deliver any further documents and do such other acts as may be reasonably necessary to effect the release of the Security Interest solely with respect to the Patent listed on Exhibit A as contemplated hereby.

### AGREEMENT

Now, therefore, Assignor agrees that it releases its security interest in the IP and reassigns to Assignee, without warranty or recourse, all interest of Assignor in the IP.


