PATENT SECURITY AGREEMENT

THIS PATENT SECURITY AGREEMENT (this "**Agreement**"), is dated as of November 16, 2016, and is by Continental Commercial Products, LLC, a Delaware limited liability company ("**Grantor**"), in favor of Encina Business Credit SPV, LLC, as agent for the lenders under the Credit Agreement ("**Agent**").

RECITALS

A. Grantor, Katy Industries, Inc., a Delaware corporation, 2155735 Ontario Inc., an Ontario corporation, and CCP Canada Inc., an Ontario corporation, FTW Holdings, Inc., a Delaware corporation, Fort Wayne Plastics, Inc., an Indiana corporation, and Agent have entered into a Credit and Security Agreement dated as of November 16, 2016 (as amended, restated, supplemented or otherwise modified from time to time, the "**Credit Agreement**"), pursuant to which Agent has agreed to make loans to Grantor and issue letters of credit on behalf of Grantor.

B. Pursuant to the Credit Agreement, Grantor is required to execute and deliver to Agent this Agreement.

C. Pursuant to the Credit Agreement, Grantor has granted to Agent a security interest in substantially all the assets of Grantor, including all right, title and interest of Grantor in, to, and under all now owned and hereafter acquired patents, patent applications, and patent licenses, and all products and proceeds thereof to secure the payment and performance of the Obligations.

AGREEMENT

In consideration of the mutual agreements set forth herein and in the Credit Agreement, Grantor does hereby grant to Agent, a continuing security interest and lien in all of Grantor's right, title and interest in, to, and under the following, whether presently existing or hereafter created or acquired to secure the payment and performance of the Obligations:

1. each patent and patent application, including, without limitation, each patent and patent application referred to in Schedule I attached hereto and incorporated herein, together with any reissues, reexamination certificates, continuations, continuations-in-part, divisionals, or extensions thereof, and all goodwill associated therewith;

2. each patents license, including, without limitation, each patents license listed on Schedule 1, together with all goodwill associated therewith; and

3. all products and proceeds of the foregoing, including, without limitation, any claim by Grantor against third parties for past, present or future infringement of any patent, including, without limitation, any patent referred to in Schedule 1, any patent issued pursuant to a patent application referred to in Schedule I and any patent licensed under any patent license listed on Schedule 1 (items 1 through 3 being herein collectively referred to as the "**Patent Collateral**").

This security interest and lien is granted in conjunction with the security interests and liens granted to Agent pursuant to the Credit Agreement and subject to limitations set forth

therein. Grantor hereby acknowledges and affirms that the rights and remedies of Agent with respect to the security interests and liens in the Patent Collateral made and granted hereby are more fully set forth in the Credit Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein. Capitalized terms used but not defined herein have the respective meanings ascribed thereto in the Credit Agreement. This Agreement is made under and shall be governed by the internal laws of the State of Illinois applicable to contracts made and to be performed entirely within such state, without regarding to conflict of laws principles thereunder.
