RELEASE OF SECURITY INTEREST IN PATENTS

This **RELEASE OF SECURITY INTEREST IN PATENTS** (this “Release”) is dated as of November 18, 2016 by Royal Bank of Canada, in its capacity as collateral agent for the Lenders (together with any successors and permitted assigns thereto in such capacity, the “Collateral Agent”), in favor of Coating Excellence International, LLC (the “Grantor”). All capitalized terms used but not otherwise defined herein have the meanings given to them in the Patent Security Agreement (as defined below) and if not defined therein, then the meanings given in the Guarantee and Collateral Agreement (as defined below) or the Credit Agreement (as defined below), as the case may be.

WHEREAS, pursuant to that certain First Lien Credit Agreement dated as of August 18, 2015 (as amended, restated, supplemented, or otherwise modified from time to time, the “Credit Agreement”), and that certain Supplement No. 1 to First Lien Guarantee and Collateral Agreement dated December 22, 2015, the Grantor became a Subsidiary Guarantor under the Guarantee and Collateral Agreement, dated as of August 18, 2015 (as amended, restated, supplemented or otherwise modified from time to time, the “Guarantee and Collateral Agreement”) and the Grantor and the Collateral Agent entered into that certain First Lien Patent Security Agreement, dated as of December 22, 2015 (as amended, restated, supplemented or otherwise modified from time to time, the “Patent Security Agreement”);

WHEREAS, the Patent Security Agreement was recorded with the United States Patent and Trademark Office on December 22, 2015 in Reel 037348, Frame 0723;

WHEREAS, pursuant to the Patent Security Agreement, the Grantor pledged and granted to the Collateral Agent, for the ratable benefit of the Secured Parties, a security interest (the “Security Interest”) in all right, title or interest in or to any and all of the following assets and properties then owned or at any time thereafter acquired by the Grantor or in which the Grantor then had or at any time thereafter may have acquired any right, title or interest (collectively, the “Patent Collateral”): (a) all letters patent of the United States, all registrations and recordings thereof, and all applications for letters patent of the United States, including registrations, recordings and pending applications in the United States Patent and Trademark Office (or any successor office), including those referred to on Schedule I attached hereto, and (b) all reissues, continuations, divisions, continuations-in-part, renewals or extensions of the foregoing, and the inventions disclosed or claimed therein, including the right to make, use and/or sell the inventions disclosed or claimed therein; and

WHEREAS, the Collateral Agent acknowledges the full payment and performance of the Obligations, and as a result desires to terminate and release the Security Interest in the Patent Collateral.

NOW, THEREFORE, for and in consideration of the foregoing, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent, on behalf of itself and the Secured Parties, hereby terminates, releases and forever discharges the Security Interest in the Patent Collateral,

and retransfers and reassigns to the Grantor, without representation or warranty of any kind, express or implied, free and clear of any claims by Collateral Agent, all right, title or interest of the Collateral Agent in, to or under the Patent Collateral.

This Release shall be governed by and construed in accordance with the laws of the State of New York.
