ASSIGNMENT

NOW, THEREFORE, for good and valuable consideration acknowledged by said Assignor to have been received in full from said Assignee, Assignor does hereby sell, assign, transfer and convey unto said Assignee, its successors and assigns, Assignor's undivided one-third (33.33%) interest in the entire right, title and interest in and to said invention for the whole of the United States and for each and every foreign country, including (1) said U.S. Letters Patent, (2) each and every foreign patent and patent application for said invention, (3) the right to enforce the same for past and future infringements, and (4) the right to collect all remuneration for past and future infringements including compensatory and punitive damages, to seek and obtain injunctions, and to collect attorneys fees, whether by settlement, adjudication or otherwise.

THE SAME TO BE HELD AND ENJOYED BY said Assignee, its successors and assigns, for its own use and behoof, for the life of rights in and to said invention, including to the full end of the life of the said Letters Patent of the United States and to the full end of the life of any foreign patent which exists or
