## TRANSFER OF PATENT RIGHTS

WHEREAS Barco, Inc., a Delaware corporation headquartered at 3059 Premiere Parkway, Suite 400, Duluth, GA 30097 USA, and with a location at 1289 Anvilwood Ave., Sunnyvale, CA 94089 USA, hereinafter called "the Transferor", has obtained the entire worldwide right, title and interest to the invention described in US provisional patent application no. 62/217,172 filed on 11 September 2015, hereinafter called "the Invention", by assignment from the inventors dated 11 September 2015, which is annexed to the present agreement;

WHEREAS the said assignment includes the right to claim priority, said application, and all Letters Patent to be obtained on said application, and any related applications including any nonprovisional application, continuation, division, renewal, substitute or reissue thereof, for the full term or terms for which the same may be granted, and any nonprovisional, provisional and/or national phase patent application on which priority is claimed, hereinafter collectively called "the Patent Rights";



WHEREAS the said assignment mentions as its beneficiaries the present Transferor "and the successors and assigns thereof";

WHEREAS the Transferor is desirous of transferring its rights under the said assignment;

WHEREAS Barco NV, a Belgian corporation headquartered at President Kennedypark 35, 8500 Kortrijk, Belgium, hereinafter called "the Transferee", is desirous of acquiring the Transferor's rights under the said assignment;

NOW THEREFORE, the Transferor and the Transferee have agreed the following:

- The Transferor hereby transfers all the rights it has obtained under the said assignment, including the entire worldwide right, title and interest to the Invention and the Patent Rights, to the Transferee, who accepts the transfer.
- The Transferor shall promptly inform the inventors of the Invention (i.e., the original assignors) about the present transfer, and instruct said inventors to promptly provide the Transferee with all pertinent facts and documents relating to said application, said invention and said Letters Patent as may be known and accessible to them and to testify as to the same in any proceeding related thereto and to promptly execute and deliver to the Transferee, or the legal representative thereof, any and all papers, instruments or affidavits required to apply for, obtain, maintain and enforce said application, said invention and said Letters Patent which may be necessary or desirable to carry out the purposes hereof.
- The Transferor promises to execute and deliver any and all papers, instruments or affidavits required to perfect the present transfer of rights and to make the present transfer of rights opposable to third parties in any jurisdiction.
- The present agreement is governed by the laws of BELGIUM. The courts of BELGIUM shall have exclusive jurisdiction over any dispute arising from this agreement.
