QUITCLAIM ASSIGNMENT

This Quitclaim Assignment is by:

- Robert L. Brass, having a residence at 45 Calhoun Street; Washington Depot, CT 06794;


WHEREAS, in the PPA, Innotech warranted and represented that, as of the Effective Date, it owned all right, title and interest to the Assigned Patents;


applications as aforesaid, to issue, modify, reissue or correct the ownership records relating to any of the Assigned Patents.






