RELEASE OF SECURITY INTEREST

This Release of Security Interest ("**Release**") is made and executed for valuable consideration by each of the parties listed on the signature page hereto ("**Secured Parties**") in favor of Vigilos, Inc. ("**Vigilos**"), a Washington corporation.

A. Vigilos and Secured Parties are parties to a Note Purchase Agreement, dated as of June 25, 2004, pursuant to which Secured Parties purchased secured convertible promissory notes (the "**Notes**").

B. On September 20, 2004, there was recorded a Security Agreement in the United States Patent and Trademark Office at Reel/Frame 015147/0486 (the "**Security Agreement**").
