
PATENT ASSIGNMENT

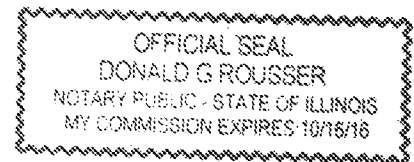


