Pursuant to RCW 23B.10.020 and 23B.10.060 of the Washington Business Corporation Act, the undersigned corporation hereby submits the following amendment to the corporation's Amended and Restated Articles of Incorporation:

1. The name of the corporation is Authentect, Inc. (the "*Corporation*").
2. Effective upon filing of these Articles of Amendment with the Secretary of State of Washington, Article I of the Amended and Restated Articles of Incorporation of the Corporation is amended to read in full as follows:
