Assignor shall from time to time and upon every reasonable request of Assignee without further consideration but at the expense of Assignee, promptly execute and deliver or cause to be executed and delivered all such further documents, deeds, assurances and instruments and shall do or cause to be done all such further acts and things as may be reasonably required by Assignee to give effect to this Patent Assignment, whether for more effectually and completely vesting in Assignee the Patents or for the purpose of registration or otherwise.


This Patent Assignment shall be governed by and construed in accordance with the laws of the Province of Quebec and the Laws of Canada applicable therein (without regard to any conflict of law principles found herein).

This Patent Assignment shall enure to the benefit of and be binding upon the parties and their respective successors and permitted assigns.
